Qualitative analysis of Criterion 1

Gramin (ACS) Mahavidyalaya is located in Vasant Nagar (Kotgyal) in Mukhed taluka of Nanded district (Maharashtra). The college has a campus of 2.5 acres with built up area of 2464 sq. mtrs with sufficient infrastructure. The college offers 16 UG Programmes in various subjects along with 52 Certificate/Ad on Courses . The college is permanently affiliated to Swami Ramanand Teerth Marathwada University Nanded. It has been observed that college provides education to students of the socially under privileged and financially weaker section. The college imparts co-education with positive gender ratio. The academic calendar is prepared by IQAC by highlighting teaching days, schedule of unit tests, Curricular and Cocurricular activities. For effective delivery, curricula are uploaded on the college website along with Academic Calendar. Nearly 10% of faculty members represent on BOS of Affiliating University. Almost all faculty members are involved in Question Paper setting and evaluation process of affiliating University. Faculty members take part in the Orientation Programme whenever the University updates the curricula. Many faculty members have attended seminars, Conferences and Workshops on the revised syllabi of their respective subjects and current issues. For effective delivery and implementation of curricular activities, the IQAC insist upon use of ICT in the teaching learning process. The college has introduced 52 value added courses to impart skill based knowledge. Curriculum enrichment programmes such as programmes on crosscutting issues are organised on the area of Professional Ethics, Gender Sensitization, Women Empowerment, Human values, Environment and Sustainability etc. The college follows the evaluation pattern prescribed by the affiliating University. All the PG students undertake courses on sensitive issues like Human rights, cyber security etc. Few courses include experimental learning through projects works, field work and internships. The College regularly collects feedback on curriculum and curriculum activities from students, teachers, employers and alumni. The collected feedback is analysed and necessary action is initiated through BOS. The faculty members record the teaching dairy and attendance regularly.

Qualitative analysis of Criterion 2

The admissions are made as per the rules laid down by the Swami Ramanand Teerth Marathawada University and Government. The average enrolment in the last five years is about 85%. Students Induction program is conducted for newly enrolled students. The faculty members gauges the learning abilities of students and explores flexible approaches to satisfy the needs of students belonging to all level of ability. Extra lectures, expert guidance etc activities are organised for effective transaction of teaching – learning process. Student Centric methods such as activity learning, student's interest, abilities and learning styles are used for enhancing learning activities. The focus is on the development of skills and enhancement of problem solving. A total of 22 faculty members have doctorate Degree, 09 faculty members have M.Phil. Degree with experience of teaching and research. In the current academic year the college has 11 Professors, 14 Associate Professors and 10 Assistant Professors.

The college registered sizable growth in number of teachers using ICT; Teachers use multimedia for presentation including YouTube

clips and allow students to respond critically to the main idea, implications, strengths and limitations of presentation. Teachers encourage students to prepare various advanced topics. The students to teacher's ratio is 30:1. In order to acquaint students with the application of the theoretical knowledge college organise Industrial visits. The college encourages students for various learning methods such as surprise tests, Group Discussion, In-house Seminars and Assignments, etc. The Continuous Internal Evaluation (CIE) committee and IQAC review the process of internal evaluation. To check the unfair means, the enquiry committee meets and grievances are traced and solved. In general the institute follows the transparent, time bound and efficient procedure for setting examination grievances. The institute adheres to the academic Calendar for conduct of CIE. Some B.O.S. members conduct meetings of the course teachers prior to finalizing the programme and the courses. All Course Outcomes (COs) and Program Outcomes (POs) are displayed on the college website and in the respective departments. Attainment of program outcomes and course outcome is continuously evaluated by the institution formally through internal examination, and theory examination.

The Institution should start the process of implementing NEP 2020 with a focus on outcome based education with proper programme outcomes (POs) and Course Outcomes (COs). POs and COs needs to be improved in the light of action verbs given in Bloom's Taxonomy. To address the academic as well as socio psychological needs of the students the college has mentor mentee system. The average pass percentage for the last five years is about 81.7%.

Qualitative analysis of Criterion 3

The College promotes research culture among the students and teachers. The college has a research cell to motivate the faculty members to apply for various projects. There are total 22 Ph.D. holders and 09 are M.Phil. holders. The college has research projects worth Rs 2.5 lakhs funded by affiliating University Swami Ramanand Teerth Marathawada University, Nanded. Three Faculty members have undertaken Minor Research Project Rs. 1 lakh in Survey of Forest Dwellars. Teachers have presented many papers in the Seminars/Conferences of National and International level. Seminars/ Conferences / Workshops were organised on Intellectual Property Right (IPR) as per National Educational Policy (NEP) 2020. A total of 271 research papers have been published and also 67 books and chapters published by the faculty members. Scopus/WoS indexed publications in high impact factor journals by the faculty members need to be encouraged.

The Department of Computer Science has developed Talking Tree Mobile Application for Botanical and Herbal Garden in the College. Another Talking Tree Device is assembled using Internet of Things, when you press on the card placed on the tree, the tree name, botanical name of the tree, family, importance, etc. will play the audio.

The college has two active NSS units, these units organises different programmes on social welfare. The students of the college participate in various rallies/programmes such as Swatch Bharat Abhiyan, save girl child campaign, Oxygen park, rally on water conservation, voter's registration awareness etc. Cleanliness drive, Tree Plantation, Blood donation camp, Special camp are some of key programmes conducted on regular basis. The College has registered satisfactory collaboration with community and non-government organisations. A total of 169 Extension activities in the neighbourhood community in terms of impact and sensitising students to social issues and holistic development were conducted during the last five year. The college has 10 active MoUs with industries/ educational institutions and has created many collaborations/ linkages. More Research facilities need to be built-up.

Qualitative analysis of Criterion 4

The institution has 2.5 acres of campus with built up area of 2464 sq. mts. The college has 16 class rooms including 11 class rooms with well equipped ICT and Wi-Fi facility and one auditorium with seating capacity of 200. There are 07 laboratories to cater to the needs of the students, Internet and Wi-Fi facility is made available in all the departments. Other provisions include botanical garden, ramps, wheel chair, CCTV Surveillance at various locations, generators/UPS, Sewage treatment plant, water purifiers canteen, and sanitization facility. Few other facilities include NSS Office, rooms for cultural activities, waiting/common room, placement cell, etc. The College has developed new botanical garden with medicinal and ornamental plants.

The college has well equipped and furnished library possesses 25520 books and 31 journals. The library is automated with Integrated Library Management system with bar coding. The library is having e-books and e-journals and reading rooms facilities. As for the computer facility the college is having 85 computers (including 31 in the computer laboratory and 10 in the Library), 12 LCD Projectors, 10 printer and 2 Digital Interactive Boards are available. The computer – students ratio is around 1:10. The institution caters the needs of the sports persons by providing play ground for various sports. Apart from this, college is having facilities for Volleyball, Kabaddi, etc. The Gymkhana houses different play areas namely Table Tennis, Carom, Chess etc. The internet access to staff and students at some locations and free Wi-Fi at various locations. The IT infrastructure in academic and administration are facilitated with broadband internet connectivity. Cultural activity in the institution is very good. There is moderate budget allocated for maintenance of buildings and playgrounds. To maintain computer, ICT equipment and IT labs college has appointed technical and support staff. One electrician is appointed for day-today electric maintenance. The computer in the computer lab needs to be replaced by the latest computer configuration.

Qualitative analysis of Criterion 5

The college has a student's council, formed on the basis of University guidelines. The college has different committees and members of student's community are adequately represented. The council indentifies the student related issues and problems. The student representatives carry out the responsibilities in consultation with the Principal, HOD and faculties. The institution avails University, State and National scholarships for the benefit of the students. A total of 36.5% of students are benefitted by various scholarships. The student's aid fund has been properly utilized by the college to needy students and the same is also used to provide incentives to outstanding performers in sports and cultural activities. The college undertakes various skill enhancement initiatives such as soft skill development programmes, English communication skills, ICT Facility, etc. The college has formed a committee for prevention of sexual harassment. The College offers guidance for competitive examinations and 36.7% students have been benefited. Guidance for competitive examinations, Career counselling and Placement cell have been established in the college campus. The institution organised placement drives in which 31% students have been placed. Many students participated in sports and cultural activities organised by the institution and other institutions. The college has an active Alumni Association which is registered and it offers its assistance in terms of contribution, donations, guidance for sports and cultural activities and organisation of various programmes. Many faculty members and the management are the alumni of the college. Some of the alumni have helped the students and college by providing the financial supports. The college has student's grievance redressal cell, Woman Development Cell and Anti-ragging Cell.

Qualitative analysis of Criterion 6

The Institution has a well-defined vision and mission for quality education and value-based education. The college has established Governing body as per the rules and regulations of UGC, Maharashtra State Government and Swami Ramanand Teerth Marathawada University. The governing council chalks out plan of action in the beginning of each academic year. The institution has a Principal who monitors and evaluates the

performance of the institution through the participative management. The institution adopts various quality improvement strategies especially in respect of ICT. The college functions with various committees, these committees plan, execute and monitor execution of admissions, examinations, teaching and learning. University statutes, rules and regulations are followed. The CDC, IQAC and various statutory and functional committees contribute to the effective and smooth functioning, governance of the college and also foster a culture of decentralization and participative management. Also institution envisages a perspective plan in consultation with the Management for academic growth and development, infrastructure development, use of ICT in administration and library. The college has introduced College Management System (CMS) software as e-governance in administration, finance, accounts, scholarships, student's admissions and examinations. Civil construction, purchase of materials, equipments is carried out with strict adherence of accounting procedures and all the documents audited and discussed in the statutory body. In the beginning of the academic year, the various bodies and committees of the college fix goals and the roadmap of action in various sectors. The college is having welfare measures for teaching and non-teaching staff namely FIP of UGC, Cooperative Society, etc. The appraisal of the staff is carried out every year according to the UGC notification and Academic Performance Indicator [API] is carried out. Study leave and financial support are granted to the faculty for attending seminars, workshops and conferences. The financial support provided to faculty members in the assessment period is about 10%. The college promotes and encourages faculty members to take part in FDPs. A total of 71 professional development programmes were attended by teaching and non-teaching staff members. The college conducts internal and external audits regularly every year by experienced Chartered Accountant (CA). The institution is government aided and hence institution depends on government grant. The IQAC of the college works in tune with the Management to improve upon the weakness and to sustain strength. The IQAC of the college conducts few meetings. The students' performance is monitored by HOD and IQAC of the college. Strategic plan needs to be implemented taking into account all the stakeholders and resource mobilisation should be enhanced.

Qualitative analysis of Criterion 7

The college has facilities for Gender Equity and Sensitivity, which eliminates discriminatory practice that are barriers to full participation for either gender. The Women Empowerment Cell of the college is having major role in creating gender neutral, and to counsel girls for Peer pressure on the adolescents. To promote gender equity, the institution conducts various activities such as awareness programme on Wall Poster Presentation,

Organisation of camps, Celebration of special days and events, Health and Hygiene activities, Seminar on Gender Sensitization, Women empowerment, etc. The college focuses on the use of alternate sources such as use of LED and solar energy. The college has drip irrigation system and rain water harvesting units. The girls and boys have separate common rooms that can be used for relaxation as and when required in the college. The college garbage in the form of solid, liquid and e-waste is disposed off with the help of the Waste Collecting Vehicles. The college campus environment is pollution free. Energy audit, Green audit and Environmental audit of the college campus is done by government recognised private agency. Institute organizes Birth / Death Anniversaries of the great national personalities. A few inclusive environment activities such as Constitution day, Participation of students in Human rights day, Red ribbon club activities, Marathi bhasha din, and Voting awareness programmes, etc. The college maintains complete transparency in its financial, academic and auxiliary function. The best practices of the college namely 'Vidyarathi Dattak Yojana' and 'Women Empowerment Programme' have been implemented successfully. The Awareness among the people regarding water management and water conservation is created through different programs. The distinctive feature of the institution is 'Average percentage of students from socially-backward category enrolled in the last five years is 66.3%.

The College should engage with the alumni and other stakeholders in the Governance process for the development of the College.
